

**REGULATIONS**  
**of the Competition for Medals and Distinctions of Kielce Trade Fairs**  
**at the stom-TOOL, stom-BLECH & Cutting, stom-ROBOTICS, stom-LASER, WELDING,**  
**stom –Fix 2024**

**I. Competition Organizers**

The competition is organized by Kielce Trade Fairs..

**II. Purpose of the Competition**

The purpose of the Competition is to promote the best products exhibited at the fairs.

**III. Conditions for entry to the Competition**

1. Entry to the Competition is open to every company which has submitted an application for participation at the fairs and has paid a handling fee of **922,50 PLN brutto** per each product entered for the Competition to:

2. Another condition for entry to the Competition is posting **by 18 March 2024 (07.00p.m.)**, a completed **entry form**, as shown in the pattern enclosed with these regulations, to the address of Kielce Trade Fairs. (The entry form may be send by e-mail). Each exhibitor may submit an unlimited number of products for the Competition.

3. Product entered for the Competition should be exhibited at the Entrant's stand and labelled as "Product entered for the Competition".

**In view of eventual large dimensions of a entered product, organisers permit to have its fragments (eg. parts of machine/equipment, installation) or the final on the stand. Therefore for entered product good evaluation, Competition Entry Form should be completed with models, miniatures, dummies, photographs of products, drawings, references, technical specification etc.**

4. Application for entry to the Competition means that the Competition participant gives consent for free use of the given information and photographs in publications of Kielce Trade Fairs and in the co-operating mass media.

**IV. Categories of products entered for the Competition.**

- the range of items permitted to be entered for the Competition encompasses products, designs or technical solutions included in the thematic scope of the **stom-TOOL, stom-BLECH & Cutting, stom-ROBOTICS, stom-LASER, WELDING, stom-Fix**

**V. Criteria and the assessment scale.**

1. Products entered for the Competition will be assessed by the Competition Jury within:

- usefulness and functionality,

- modernity of applied solutions,
- operation, maintenance and service friendliness,
- design and aesthetic qualities.

The Jury may also establish other criteria of assessment.

## **VI. The Jury.**

1. The Competition Jury is appointed by Kielce Trade Fairs.
2. Sessions of the Competition Jury are chaired by Chairperson of the Competition Jury, chosen from among members of the Competition Jury, while secretarial and clerical services are provided by Kielce Trade Fairs.
3. Kielce Trade Fairs may appoint experts whose task would be to prepare opinions on entered products in particular categories and who may participate in the Competition Jury sessions in an advisory capacity.
4. Any materials in possession of the Competition Jury are confidential and will not be made available to third persons.
5. The Competition Jury may exclude from the Competition products which are not accompanied by proper documents or which require long-term expert testing to assess their qualities.
6. Medals and Distinctions in particular categories are awarded by the Competition Jury through voting. Minutes of the Competition Jury sessions will be taken.
7. Deadline:  
**18 March until 7.00 p.m. 2024 – admitting applications (till)**  
**19 March 2024 – session of the Jury**  
**20 March 2024 – announcement of the results, presentation of Medals and distinctions**

## **VII. Prizes**

1. The main prize in each category is the Medal of Kielce Trade Fairs. Distinctions are in the form of diplomas funded by Kielce Trade Fairs - the Competition organizer.
2. The Competition Jury reserves the right not to award the Medal or Distinctions in particular categories.
3. Winners of Medals and Diplomas have the right to place signs thereof on the awarded products.
4. Kielce Trade Fairs also award a Medal and Distinctions for stand arrangement and promotion technique. In this category submission of an entry form is not required. All stands presented at the trade fair are considered.
