Regulations for the ENEX AWARD Contest and Special Recognition of the Kielce Trade Fair at the ENEX 2025 Trade Show

I. Organizers of the Contest

The organizer of the contest is Targi Kielce.

II. Purpose of the Contest

The purpose of the contest is to promote the best products showcased at the ENEX trade fair.

III. Conditions for Participation in the Contest

1. Eligibility for Participation

Any company participating in the ENEX trade fair is eligible to enter the contest, provided it pays a handling fee of 500 PLN net per product submitted. Payment should be made to:

2. Submission Deadline

To qualify, products must also be registered through the client portal at:

<https://portalklienta.targikielce.pl/auth/login> under the "contest" tab. The submission **deadline is February 6, 2025, at 3:00 PM**. Exhibitors may submit any number of products to the contest.

3. Resentation Requirements

The submitted product must be displayed at the submitter's booth and marked with the label: "Product Submitted for the Contest." A physical object or product must be submitted for evaluation. Due to size constraints, partial components (e.g., machine parts) or final products may be displayed. To facilitate assessment, supplementary materials such as models, miniatures, mock-ups, photos, videos, technical drawings, certifications, references, or other relevant documentation are recommended.

4. Consent for Use of Materials

By submitting to the contest, participants consent to the free use of the provided information and images in Targi Kielce's publications and in media outlets associated with the trade fair.

IV. Categories of Products Submitted to the Contest

1. Solar Energy
2. Energy Storage
3. Electromobility
4. Heat Pumps
5. Biomass Energy
6. Energy Management
7. Hybrid Energy Systems
8. Innovations in Renewable Energy Sources (RES)
9. Other

V. Criteria and Scoring Scale

The products submitted to the contest will be evaluated by the jury based on the following criteria:

- Utility and functionality
- Modernity of the applied solutions
- Serviceability and ease of repair
- External appearance and aesthetics

The jury may also establish additional evaluation criteria.

VI. Jury

1. The Contest Jury is appointed by Targi Kielce.
2. The Jury meets under the leadership of the Jury Chairman, elected from among the Jury members, with the secretariat and office support provided by Targi Kielce.
3. Targi Kielce may appoint experts whose role is to prepare opinions on the submitted products in specific contest categories. These experts may participate in the Jury meetings with an advisory vote.
4. The Jury's proceedings are in two stages:
 - **Stage 1** – Selection of the most interesting products based on the submitted applications.
 - **Stage 2** – Visit to selected booths, scheduled for February 18, 2025.
5. All materials and activities of the Jury are confidential and will not be shared with third parties.
6. The Jury may exclude from evaluation products lacking proper documentation or requiring long-term specialized testing to assess the product's qualities.
7. The **ENEX Award** and **Special Recognition** in each contest category are granted by the Jury through voting. The Jury meetings are recorded in minutes. The decisions of the Contest Jury are final.
8. The results and the award ceremony for the **ENEX Award** and **Special Recognition** will take place during the event on the first day of the trade fair, February 18, 2025.

VII. Awards

1. The main prize in each category is the Enex Award statuette. Special Recognitions are diplomas funded by Targi Kielce, the contest organizers.
2. The Jury has the right to refrain from awarding the statuette or any special recognitions.
3. Winners of the statuettes and diplomas have the right to display the image of the award on the products that won.
4. Additionally, Targi Kielce will present TOP DESIGN Awards and Recognitions for booth design and promotional efforts. No registration is required for this category. All booths presented at the trade fair will be considered.
