Enex Award Competition and Targi Kielce Distinctions at Enex 2026

I. Organizers of the Competition

The organizer of the competition is Targi Kielce.

II. Purpose of the Competition

The purpose of the competition is to promote the best products presented at the Enex 2026 Fair.

III. Conditions for Participation

- Any company registered as an exhibitor at the Enex Fair may participate in the Competition, provided that it has paid a handling fee of PLN 500 net for each product submitted, to the following account: Targi Kielce S.A., Bank: BNP Paribas Bank Polska S.A., Account number: PL 22 1750 1110 0000 0000 0568 3537, SWIFT: PPABPLPKXXX
- 2. To be accepted for the Competition, an application must also be submitted via the Exhibitor Portal, in the "Competition" section, no later than February 26, 2026, by 4:00 p.m. Each exhibitor may submit any number of products.
- 3. The product submitted to the Competition must be displayed at the exhibitor's stand and marked with the label: "Product entered in the Competition." The entry should represent an actual object/product. However, due to size, it is acceptable to display only parts of the object (e.g. machine components) or the final product of the submitted entry. In such cases, to enable proper evaluation, the entry should be supplemented with models, miniatures, mock-ups, photographs, videos, drawings, technical descriptions, certificates, references, or other relevant materials.
- 4. Submission to the Competition also constitutes consent for free use of the submitted information and photos in publications by Targi Kielce and cooperating media.

V. Evaluation Criteria and Scoring

The Jury will evaluate the submitted products based on:

- Functional and practical qualities
- Modernity of applied solutions
- Ease of maintenance and serviceability
- · Design and aesthetic value
- The Jury may also establish additional evaluation criteria.

VI. Jury

- 1. The Competition Jury is appointed by Targi Kielce.
- 2. The Jury operates under the direction of a Chairperson, elected from among its members. Targi Kielce provides secretarial and administrative support.
- 3. Targi Kielce may appoint experts to prepare opinions on the submitted products in specific categories. These experts may participate in Jury meetings in an advisory capacity.
- 4. The Jury's work consists of two stages:
 - Stage 1: Selection of the most interesting products based on submitted applications.
 - Stage 2: On-site evaluation of selected products at exhibitors' stands.
- 5. All Jury materials and proceedings are confidential and will not be made available to third parties.
- 6. The Jury may exclude from evaluation any products lacking proper documentation or requiring lengthy specialized testing to determine their qualities.
- 7. The Enex Award and distinctions in each category are granted by Jury vote. Jury meetings are officially recorded, and decisions are final.
- 8. The announcement of results and the awards ceremony will take place on March 4, 2026, during the first day of the Enex Fair.

VII. Awards

- 1. The main prize in each category is the Enex Award statuette. Distinctions will be awarded as diplomas, funded by Targi Kielce, the organizer of the Competition.
- 2. The Jury reserves the right not to grant a statuette or distinction in a given category.
- 3. Winners of statuettes and diplomas are entitled to label their awarded products with the Enex Award emblem.
- 4. Additionally, Targi Kielce will grant awards for stand design and promotional presentation. No application is required for this category all stands presented at Enex are automatically considered.
